USE OF PARKS AND RESERVES

POLICY STATEMENT

SPORTS AND GAMES

- a. That Council reaffirm the setting apart of the following areas for the playing of sports or games:
 - i. Boronia Park Oval
 - ii. Boronia Park No. 2 Ground and Netball Courts
 - iii. Boronia Park No. 3 Ground
 - iv. Gladesville Reserve Playing Field and Netball Courts
 - v. Weil Park Playing Field and Tennis Practice Court.
- b. That organised sport be permitted on Sundays on playing fields in the Municipality, under the control of the Council and set apart for that purpose, subject to the following regulations:
 - i. Commencement of play being restricted to not earlier than 10.00 a.m.
- ii. One of the participating teams being recognised as a local team or, at least, having substantial local representation affiliation or responsibility.

Note: "Local" means postcode districts 2110 and 2111.

- iii. Applications to be submitted in writing.
- iv. Payment to be made in advance of the appropriate charge or permit fee.
- c. That the Town Clerk be authorised to deal with applications for use of playing fields on Sundays and Public Holidays and to attach conditions to any approval appropriate to the use of the ground.

2. PICNICS AND ASSEMBLIES

- a. That the following areas be set apart in terms of Clause 21 of Ordinance 48 for the purpose of group activities including picnics, public performances, celebrations and similar assemblies:
 - i. Boronia Park Oval
 - ii. Boronia Park No. 2 Ground
 - iii. Boronia Park No. 3 Ground
 - iv Gladesville Reserve Playing field
 - v. Weil Park
 - vi. Clarke's Point Old Slipway Area
 - vii. Clarke's Point Headland Area.
- b. That the Town Clerk be authorised to deal with applications for use of picnic areas and other reserves and to attach conditions including:

- i. The ground being left in a clean and tidy condition.
- ii. No motor vehicle to be driven onto the reserve without special approval.
- No tent or other structure of any kind to be erected on the reserve without special approval.
